

# 5 STEPS TO MANAGING SALES TAX FOR SOFTWARE COMPANIES

The world of sales tax can be extremely confusing – sometimes even more so if you're in the software industry – but getting it right is crucial for success. As your business evolves, your sales tax obligations may also change or expand. And when that happens there are typically five steps you need to take in order to ensure you're compliant at every stage of the sales tax cycle. To help, we've identified the five steps for managing sales tax all companies should take to achieve compliance. Be sure to pay special attention to Step 1 and Step 3, as these are especially relevant and can be even more challenging for those in the software industry.







# STEP 1: KNOW WHERE YOUR BUSINESS MUST COLLECT AND REMIT SALES TAX

# **OVERVIEW**

You may not need to collect and remit sales tax everywhere, so determining where your business is required to collect and remit is the first step to sales tax compliance. The connection that establishes a business obligation to collect and remit tax is a concept known as <u>nexus</u>. Many business activities can create a nexus obligation with a tax jurisdiction, including having physical locations, remote employees, affiliate relationships, or economic activity in that tax jurisdiction.

There are a few business activities software vendors should pay close attention to, as they tend to be some of the more common triggers for establishing a nexus obligation. These include hiring new or remote employees, launching new products, and migrating products or services to the cloud. While many industries may encounter these business changes, software companies tend to do them more frequently.

**New employees:** Hiring new employees or remote staff – including contractors – establishes nexus in many states. Software companies tend to grow rapidly and thanks to technology, aren't limited in where they hire. Many have a workforce spread across the country, so this business activity is often a nexus triggering event for software companies.

**Launching products:** Any time a software company launches a new product or expands into a new market, there's an opportunity for new customers in new locations. But expanding or launching new products or services into new markets can also create a new nexus obligation. Due to the recent rise in economic nexus laws, many states now base nexus obligations on economic activity, including reaching sales and/or transaction thresholds.

**Migrating products or services to the cloud:** Migrating existing products or services to the cloud and/or starting to sell new products or services online might create nexus in new jurisdictions. Some jurisdictions include digital goods and services in their economic nexus thresholds, while others don't. If you sell cloud software or services, you need to understand what types of sales are included for jurisdictions with economic nexus thresholds.



# STEP 1: KNOW WHERE YOUR BUSINESS MUST COLLECT AND REMIT SALES TAX

## WHAT TO DO

First, understand the business activities that can create a nexus obligation, then review your business activities to determine where you may have a requirement. The business activities highlighted above are just a few of the ways you can establish a nexus obligation, so it's important to understand the entire list. Also, stay informed of changes in legislation that may affect state and local tax jurisdictions as nexus laws change frequently. # STEP 2: REGISTER TO COLLECT AND REMIT SALES TAX

## **OVERVIEW**

After you determine where you have nexus, and subsequently where you're obligated to collect and remit sales tax, you must register in the appropriate tax jurisdiction. Unfortunately, the process, forms, and requirements to register aren't the same for all state or local tax jurisdictions. In most jurisdictions, you must register prior to legally collecting and remitting sales tax from your customers within each separately administered tax jurisdiction, so be sure to take care of this step before moving to Step 3.

It's important to note that if you realize in Step 1 that your software business previously established nexus in a jurisdiction where you're not registered and collecting sales tax, you may have a past tax liability that has gone unaddressed. To rectify this situation, you may need to take additional steps to become compliant with the tax jurisdiction, such as backfiling unpaid taxes or participating in a voluntary disclosure agreement.

# WHAT TO DO

Understand where you need to register and what licenses, forms, and registrations should be completed before you start collecting and remitting. All states and jurisdictions are not created equal when it comes to getting set up, so it's critical you're aware of the individual specifications for businesses that produce and sell software.

# STEP 3: CALCULATE THE CORRECT SALES TAX AMOUNT

# **OVERVIEW**

Once you're registered in the tax jurisdictions where you have a nexus obligation, you're ready to start calculating and collecting sales tax. There are more than 13,000 tax jurisdictions in the United States, and each jurisdiction has different tax rates and product taxability rules, so it can be difficult to know what tax rate to charge.

When it comes to software sales, there are many variables that impact whether a jurisdiction imposes sales tax. Is the software delivered physically or digitally? Is it custom or canned software? The list of variables goes on.

The complexity of product taxability within the software industry can create more work and confusion for software vendors. Although it can be difficult, it's crucial to get it right so you avoid collecting tax when software is exempt, but ensure you're collecting tax when software is taxable.

To help illustrate the complexity and the variety of ways states approach enforcing the taxability of software, we highlighted three states below. To see a comprehensive state-by-state software taxability report, read our **software taxability by state guide**.

Hawaii – All software is taxable.

- Prewritten software delivered on physical media Taxable
- Prewritten software delivered electronically Taxable
- Customization of canned software Taxable
- Cloud services Software as a Service (SaaS) Taxable
- Custom software delivered on physical media Taxable
- Custom software delivered electronically Taxable

Arkansas – In general, software is exempt.

- Prewritten software delivered on physical media Taxable
- Prewritten software delivered electronically Exempt
- Customization of canned software Exempt
- Cloud Services SaaS Exempt
- Custom software delivered on physical media Taxable
- Custom software delivered electronically Exempt

# **STEP 3: CALCULATE THE CORRECT SALES TAX AMOUNT**

New York - Software is split 50/50 between taxable and exempt.

- Customization of canned software Exempt
- Cloud Services SaaS Taxable
- Custom software delivered on physical media Exempt
- Custom software delivered electronically Exempt

# STEP 4: TRACK AND MANAGE EXEMPT SALES

## **OVERVIEW**

Depending on the nature of the business or the intended use of the product for sale, a business may be exempt from paying sales tax on a transaction. For example, many states don't require nonprofits and government agencies to pay sales tax. In addition, products intended for resale are typically exempt from sales tax in some states. Regardless of the reason for an exemption, the seller must collect and manage an exemption certificate to validate and confirm why sales tax wasn't collected. Failure to produce up-to-date documentation during an audit may leave businesses open to penalties and fines.

# WHAT TO DO

If your business deals with exempt sales, make sure you have a process in place to collect, track, and validate exemption certificates from your buyers. Neglecting to collect tax coupled with missing or expired exemption certificates is one of the top reasons businesses are assessed penalties during an audit. See to it that your process doesn't leave you open to this risk or cause you headaches by inaccurately charging sales tax when a sale should be exempt.

Now that you've collected the appropriate sales tax amounts, it's time to remit those funds to the tax authorities. Each tax authority has unique regulations around sales tax remittance, including when sales tax returns are due, how they should be remitted (either via paper returns or electronic returns), and the frequency returns must be remitted to the tax jurisdiction.

Be certain you understand the filing requirements for each jurisdiction where you collect tax and have a plan or solution in place to file those returns when they're due. Determining your sales tax liability for your software business, what tax forms are required, and how to remit the tax can be incredibly time-consuming, so make sure you have dedicated resources for this every filing period.


